Breanne Johnson WDB Nomination Review and Approval: Nomination for WDB Breanne Johnson move by Commissioner Leiviska to accept nomination, second by Commissioner Roche, unanimously passed and approved.

Joint Powers Agreement Follow Up: Joint powers agreement follow up, Marie requested commissioners reach out to Administrators to continue to move the process forward. Aitkin county moving forward, questions answered by our attorneys. St. Louis also had a few questions about joint powers agreement. Carlton was good to go. Itasca has not responded. Koochiching will meet with the administrator tomorrow. The Aitkin board needs a meeting for approval. When counties all approve, a copy will be circulated for approval. Will look into a deadline for having it back, update due to new commissioners. June/or July 2023 Joint Powers Agreement update. Marie will look at timeline for update. (5 years / 3 years). It will follows the Joint Powers Act.

Workforce Development Board Update Composition removals. Completed. Met with 5 WDB folks Kelly Hertling, Wayne, Desi, Becca, Eric James were at meeting. Commissioners Levisa and Proulx were present via zoom and Commissioner Ives in person, Tara was in person as well. Explained issues and concerns. Have had a phone call with Kelly, who is the L&M

Radiator HR person. That company has been sold and has a new owner. She is stepping down to attend to the responsibilities of L&M and sale. Issues and concerns they brought forward. Some valid, some not, need further discussion. Worthy of time and investigation. MN Deed asked us to have that meeting, which we agreed to. Tom: first time I have met with these people. Travis: well worth the time to meet with them and good information shared. Burl: on the right track we need other representation from our counties. All counties should be represented. Volunteer effort and it needs to change a bit. Rick, no one in lake county yet. Direction is good that we are going. Ricky PCA Tracy Saari and Greentech manufacturing nominee will be forthcoming.

Funding Summary: Everything is 80% spent, waiver in place for youth 042. On federal grant we would like to have carry over, so 1st quarter of the year we need a buffer for sequestration. We use it to cover the 1st quarter for staff and admin costs, so we never want to spend out 100%. High increase in our youth funds large increase and dislocated worker funds. MFIP and DWP monies are separate for some counties and combined for others. AEOA is in all counties. Lake uses AEOA and Cook utilizes. We only report to counties quarterly, transaction has to happen at the time. Contract with Lake and Cook AEOA, contract with AEOA person who travels throughout county.
