Presentation covered what WIOA is all about, how and why the workforce development boards are established, the one stop system, and employment and training services provided through WIOA Title I programs for youth, adults, dislocated workers and incumbent worker services. WIOA Reauthorization - Marie

Handout, GLEDA is USDOL region 5, WIOA currently is up for reauthorization. GLEDA has provided some recommendations. They work with workforce development directors to identify gaps in the law and author recommendations upholding the WIOA key principals. This handout includes these recommendations including topics such as freedom and flexibility in funding, business lead, business and employer focused programs. Currently there are unfunded portions, like the workforce development board, unfunded business services. Please support and reach out to your legislators to reauthorize the WIOA rule.

DEED Regional Staff Presentations - Labor Market Analyst - Carson Gorecki

Carson Gorecki presented the 2023 Regional Profile as well as a summary of what the Labor Market Information Office does. It is to share data and information to make informed decisions in Minnesota. Employment statistics, salaries, wages, employment rates, jobs numbers, detailed wage data, graduate employment outcomes. Also touched on a new tool that was released, about what is your major and what is your wage 7 years out. The complete presentation was emailed to all board members.

DEED Regional Staff Presentations - Workforce Strategy Consultant - Shayla Drake

Shayla Drake, Workforce Strategy Consultant, presented on services available to help the seven county Arrowhead Region. Employers are impacted by the decisions of the board, the training and services in the area will dictate programs available to the workforce in the region. We will work together to develop a plan to meet regional demands and needs. The board identifies which areas to focus on to benefit the region most. Housing, transportation, and childcare are big 3 barriers, the board can help move the needle to reducing barriers. Workforce strategy consultants can also help employers one on one from start to finish on brand awareness, onboarding, training, upskilling, diversity equity and inclusion.
